Selected Cases and Representation

- Lundy v. King Real Estate, LLC, 1:20-CV-01764 (S.D. Ind. 2021)
- · Obtained summary judgment and recovered attorney fees for her client, a property owner, on claims asserting negligence and negligence per se arising from an alleged dog bite on the premises.
