He authored the chapter on eminent domain which is included in the Indiana Elected Municipal Officials Handbook, published by the Indiana Association of Cities and Towns, and is a co-author of the chapter of Indiana law on eminent domain for the ABA. Mike was also director of the Roncalli High School Mock Trial Program and received a statewide award in 2009 for his efforts with the Indiana Mock Trial Program. He was a member of the steering committee and finance chair for the 2013 National High School Mock Trial competition in Indianapolis, where 48 teams from across the country and beyond competed. Mike continues to work with the Indiana Bar Foundation on growing the High School Mock Trial Program in Indiana and is now a member of the Indiana Bar Foundation High School Mock Trial Advisory Committee. For 10 years, Mike served on the Board of Directors with the United Way Youth as Resources program, including two years as chairman.
